Re: *Head Start Funding for FY 2010*

Dear Chairman Harkin and Ranking Member Specter:

Thank you for your strong and continued support of Head Start and Early Head Start (collectively "Head Start"), the nation's premiere early childhood education and care programs providing comprehensive school readiness, education, health, nutrition, and parent involvement services to low-income children ages birth to five and their families.

To make a down payment on the President's "Zero to Five" Plan and build on the recent investments in early childhood education and care in the American Recovery and Reinvestment Act of 2009, we hope that you will consider providing \$8,112,786,000 for activities under the Head Start Act for FY 2010 Appropriations. This amount will foster sustainable growth in Head Start, Early Head Start, Migrant and Seasonal Head Start, and American Indian/Alaska Native Head Start programs across the country and allow Head Start programs' base funding to keep up with the pace of inflation since 2002.

Studies have demonstrated that funding spent on the Head Start program earns a high return on the investment for society. Its benefits include increased educational achievement, improved health outcomes, higher expected future earnings, better employment opportunities, and increased family stability. Children enrolled in Head Start have a lower risk of welfare dependency, criminal behavior, grade repetition, and special education than their counterparts without the benefit of Head Start.

We are proud to represent Head Start programs across the country and look forward to continued efforts to ensure that more children and families who need Head Start services can receive them. Thank you for your consideration of this request and for all that you do for Head Start children and families.
